




#### Flexible reports

We offer a range of standard reports, and lots of options to create your own customized reports on companies and individuals. And you can export reports in a variety of formats.

#### Screen and assess risks

Using Compliance Catalyst, which is powered by Orbis, you can screen companies and individuals across PEPs and sanction lists according to your own risk models. You can also:

- assess risks associated with individuals and companies using more than 50 risk categories
- access information relating to PEPs' family members and close friends
- screen corporate groups for links to PEPs and sanctions



# Integrate data from Orbis into your systems and workflow

You can use data from Orbis in your own systems and blend it with your own external data. For example, you can use Orbis data with your internal data sets such as your own blacklists, and internal intelligence on individuals or companies. You can use our Web Services Kit for these integration projects, or choose from a range of Apps for specific systems.

Orbis is compatible with Visual Company Analyzer, a desktop application that integrates with IBM i2 Analyst's Notebook, that's widely-used by intelligence services for data visualization and analytics.

#### **Ownership Explorer**


Ownership Explorer helps you to visualize ownership structures, find beneficial owners, controlling shareholders, and individuals and companies that are sanctioned by extension.

You can also identify which companies are controlled by Specially Designated Nationals (SDNs) and generate snapshot lists of companies that are "sanctioned by extension"<sup>2</sup>. In the case of the Russian individuals targeted by US sanctions in April 2018, Orbis identified that these new SDNs are the 50% owners of more than 1,300 corporate holdings. For example, using Orbis we've tracked the ownership of a US registered company to one of the newly appointed SDNs (see image below).

#### Access data securely and anonymously

Orbis provides secure data access through a web-based desktop platform.

Specifically for intelligence services, we also offer an anonymous usage option where your usage will not be tracked or recorded, and neither will your search requests.



<sup>&</sup>lt;sup>2</sup> Under OFAC's 50% rule, if an unbroken chain of ownership links leads to full or part-ownership of a company by a sanctioned individual or entity; and in none of the chains is the ownership share less than 50%, then that company is also sanctioned by extension.
