Market indicators and credit ratings

Credit Default Swap (CDS)

BankFocus calculates daily implied CDS spreads, provides implied ratings with historical data and offers graphical peer comparison functionality. All of this is done using statistically significant factors, including:

- aggregated information from the CDS market
- the Financial Implied Rating
- additional financial ratios
- distance-to-default information derived from the equity market




